Episode 7: Threats

Doctor Samuel Elder (Travis)

Jasper Cole, Newspaperman (Andrew)

Boy, the Mysterious Stranger (Bob)

“Honest” Harvey Boone, Attorney at Law (Pete)

Sheriff J.J. Sherman (Craig)

Judge: Dave N.

December 1

Sheriff Jim: The sheriff is threatened by Carl Kincaid, U.S. Deputy Marshal, to cease and desist his activities or face the consequences.

Jasper: Sidewinder Combs busts in with Jerry Seinfeld. They fight, Jerry sets the newspaper office on fire, Jasper, wounded, shoots Sidewinder dead and Jerry runs off.

Boy: Boy spots Oliver Queen wearing his dead Pappy’s hat, Boy chases him down, but Queen is joined by Dick Van D, Ralph Wiggum, Big Watson. Boy knocks out Queen, Watson and Ralph Wiggum, and Dick Van Dyke runs off. Queen reveals that he and his chums are based in Diggsburg.

Harvey: Portuguese Falco delivers Harvey a subpoena to report to the federal courthouse in Phoenix to give testimony about possible jury tampering.

Dr Elder, summoned by Damp Weeds, the new jailer, to the jail to see to a sick prisoner. The prisoner, Pablo Ramirez, the gun-runner, has a hidden gun and shoots at Elder, but misses. Elder shoots back and kills Ramirez dead.

The posse gathers and discovers that first Kincaid had ordered Swifty at the telegraph office had been ordered not to let the Sheriff send any telegrams, and later on the lines themselves were cut. They decide that Richard Evans must be making his move and that the settlers and allies must be gathered together to resist him.

The Sheriff and Harvey goes to Bar-K ranch. They talk with Wrangler Steve who gets them into the big house. They meet with Jeffery Hunter who agrees to help them against Evans.

Jasper, Boy and Dr. Elder go to dispense the guns to homesteaders, to Goslings and Abigail in particular, give them guns and ammo. They try to get them to reveal the source of the guns. Abigail reveals to Jasper that she and Margot are sisters and Margot was sending cash and guns.

December 2

The posse gather back in town and decide to go to Diggsburg.

At Diggsburg, Jasper and Boy go to Nevada Bob's bar, Jasper gets Jerry Seinfeld to join them. They take Jerry for a walk. Boy knocks out Jerry and straps him to his horse and rides off and disposes of him.

Harvey, Jim and Doc go to mining office. They extensively question Frank Drevin the mine manager. They find out about Mine Detectives gathering in town and the low down on the Diggsburg Mining Company (corporate secretary Danny Thomas). They decide to ignore the Mine Detectives and return to Hacksaw Crossing.

December 3

Everyone confronts Margot and Wilma and kept their suspicions aflame, but can't find any real proof that the pair are the Old Man Bandits, saying the money and guns were all from gambling winnings. The posse goes to Goslings and discover that Margot was lying about "gambling". Boy reads assay books and finds the homesteaders' lands probably are full of gold. Jasper questions Condron at bank about Drysdale. He then goes to First National gets a loan to repair his office. Boy finds out from Little Timmy that his uncle Medium Timmy had taken dinner to Pablo Ramirez and went off to Triple ZZZ.

The posse waits for the homesteaders and the crew from the Bar-K ranch to gather in town so they can deal with Richard Evans once and for all.
